Chair Stebbins called the meeting to order at 10:05 am in 217 Grappone, NHTI, Concord, NH.

Approval of Meeting Minutes

VOTE: The Committee, on motion of Ms. Shields and seconded by Ms. Roy-Czyzowski, voted unanimously to approve the January 23, 2018 Finance Committee minutes as written.

2018-2019 CCSNH Fees

Mr. Ansell introduced the proposed CCSNH fee changes for 2018-2019 and thanked the college presidents for working to standardize fees across colleges. Mr. Ansell discussed the proposal to eliminate the application, orientation, and graduation fees, which act as a barrier to new and graduating students, and replacing them with a \$3 comprehensive fee per credit. The clinical surcharge fee has not been increased since 1999, and the proposed increase to \$500 is closer to (but still less than) clinical surcharges among peer groups and better reflects that actual costs of these programs. The Committee reviewed the following fee changes, to be presented to the full board for final approval:

The Committee discussed the significant improvements made to communications, timing, and strategy surrounding the fee change process this year and commended senior leadership for their work.

VOTE: The Committee, on motion of Ms. Shields and seconded by Ms. Lucas voted unanimously to approve the fee changes as presented.

FY19 – FY23 Projections

Representatives from each college discussed their respective college's 5-year operating budget projections, an exercise that gives the colleges the opportunity to do contingency planning ahead of time. The projections were based on the assumptions that there will be a tuition rate change, COLA increase, benefits change, Chancellor's Office budget increase, and gains from financial sustainability efforts.

Other Business

An update on the academic centers (ATAC, Keene) will be provided at the next meeting on May 3, 2018.

No further business was stated. The meeting adjourned at 12:11 pm.
