This Addendum forms a part of the Contract Documents and modifies the Request for Bids dated February 19, 2020 with amendments and additions noted below. This Addendum consists of a total of Three (3) pages.

CLARIFICATIONS TO THE REQUEST FOR PROPOSAL:

BIDDER'S QUESTIONS

QUESTION #1:

Are the work hours definitely going to be restricted to Tuesday - Friday 8:30-9:00 and Saturday 8:30-12:00?

ANSWER #1:

These are the hours to work, because either there are classes or the building is not open.

QUESTION #2:

Will the Job Super be allowed to perform any work?

ANSWER #2:

Yes.

QUESTION #3:

The specifications call for Pollution Liability coverage that will remain in effect for 5 years after job completion. This job does not appear to carry be any exposure that would require Pollution Liability coverage - We do not typically carry Pollution Liability in our insurance portfolio, we have in the past had to pick it up for a specific job but in this case it looks like it would be an additional unnecessary cost.

ANSWER #3:

Yes, Pollution Liability Insurance is required per Instructions To Bidders 00204 Part 10.7.

QUESTION #4:

Can you confirm the deck height?

ANSWER #4:

The deck height is 8'-6"

QUESTION #5:

The reflected ceiling height does not call out the tile or height AFF for the Lab. Please verify.

ANSWER #5:

Existing ACT in Lab is at 7'-6" AFF.

QUESTION #6: What are the ceiling finishes in the abutting rooms that will be affected by the plumbing work shown on P-1?

ANSWER #6:

Adiacent existing ACT in bathroom is at 7'-6" AFF per existing drawings.

QUESTION #7: How many signs will be required and what type? A002 and A003 do not clarify and the plans do not call out any.

ANSWER #7:

None. One sign is called out on the door schedule on A601 and will be provided and installed by others.

QUESTION #8: Specification 07 21 00 calls for Rockwool insulation. Sheet A101 asks us to salvage the existing batt insulation. Can you confirm the existing is all rockwool?

ANSWER #8:

Spec permits either Rockwool or Fiberglass. Provide new insulation where called on partition types A601 (e.g. @ Control Room).

QUESTION #9:

Are there any union requirements?

ANSWER #9:

No union requirements.

QUESTION #10:

What is the estimated project value?

ANSWER #10:

The estimated project value is \$ 50,000.

QUESTION #11:

What is the start date?

ANSWER #11:

The start date is as soon as contract documents are signed and insurances have been received.
